- Standard Divisions with complex easements
- Community Divisions (excluding complex stratum divisions)

#### ➤ Premium Consulting Service (Bespoke) High Complexity

Time and materials may be quoted for plans/projects estimated by LSSA to be outside of the fixed fee time frame due to:

- containing multiple complex variation and/or extinguishment of easements
- possibly requiring an extensive 'right search'
- the complexity (i.e. large-scale Stratum Divisions)
- the size (high data content and sheet numbers)
- requiring significant consultation

#### PRODUCT SCOPE

#### ➤ Premium Consulting Service (per Dealing) \$590+GST

Division Dealings: RTU and RT

Non-Division Dealings: Variation of Order of Priority (AV), Underlease (UL), Re-Entry of Lease (RL), Lease (L) and any other non-division dealings that are intended to be lodged in the same series e.g. LMA, RA, CN, DM, M, T etc.

#### ➤ Premium Consulting Service (per Dealing) \$650+GST

Division Dealings: RTC/ACT/TG and VE (no fee for By-Laws)

Non-Division Dealings: Appointment of New Trustees (NT)

#### ➤ Premium Consulting Service (per Dealing) Bespoke Quote \$+GST

All lodged dealings requiring significant consultation.

- Containing multiple complex variation and/or extinguishment of easements
- Possibly requiring an extensive 'right search'
- The complexity (i.e. large-scale Stratum Divisions)
- Dealing complexity requiring significant consultation
- Transactions involving complex shares or interests.



➤ **Lodgement for Filing Scheme Description/Development Contract \$355+GST (Per Lodgement)**

When an ACT is lodged and is accompanied by an LF1 Scheme Description and Development Contract. This fee is charged per dealing in addition to the ACT Dealing product fee.

➤ **Lodgement for Filing Variation/Amendment of Scheme Description/Development Contract \$355+GST (Per Lodgement)**

When an AP3 or AP5 is lodged and is accompanied by an LF2 Scheme Description and Development Contract. This fee is charged per dealing in addition to the AP3 or AP5 Dealing product fee.
