CHANGES TO TATS SEARCHES AND OUTPUTS

A number of changes have been made to clarify the presentation of information on Torrens Automated Title System (TATS) searches and outputs. These changes are listed below and will take effect from 24 April 1996.

Client Reference

A new field has been added to the Register Search request screen (AFARSH) to allow the input of up to 6 characters of any type as a client reference number or code. Input of data to this field is optional.

The client reference number or code will be printed on the top left hand comer of the Register Search alongside the cost of the search.

Authority

TATS Register Searches and certificates of title issued through the conversion process have, until now, shown as an authority a fabricated document number CD 6987000. This document number will be replaced with the words "CONVERTED TITLE".

Parent Title on Register Search

Reference to the parent title will be included on TATS Register Searches. Where there is more than one parent title the words "& OTHERS" will be displayed with the first parent title reference.

Certificate of Title Reference

On all TATS Register Searches, except those delivered by fax, the title reference will be shown in bold print.

A sample Register Search incorporating the above changes is attached.

Some further changes will be made to TATS searches in the future to make the wording on all of the searches and outputs consistent.
